Sealed offers are invited in two bid system from the eligible resourceful manufacturers of SPV system for Design, manufacture, supply, erection, installation, testing and commissioning of Solar Photovoltaic Array of capacity 25kWp. 15	Minimum Eligibility Criteria	<p>The firm must have a minimum annual turnover of Rs 5.00 crore over last two financial years (2009-10, 2010-11) exclusively in the business of solar PV systems alone.</p> <p>The firm must have designed, manufactured, tested, supplied, installed and commissioned minimum plant capacity of 200 kW (Cumulative) in the range of 20 kW and above and which is/are in successful operation on the date of bid opening.</p> <p>The firm must have valid VAT/PAN/PF/TRADE and Service Tax registration certificate.</p> <p>Systems offered shall be indigenous make & not fully imported.</p> <p>The bidder should have ISO 9001, 14001 certificates.</p> <p>SPV Systems must have design qualification and type approval from the accredited testing centre as per guidelines of Jawaharlal Nehru National Solar Mission as clearly mentioned in the order of MNRE Govt of India, issued in vide No. 5/23/2009-P&CDated: 16.6.2010 and subsequent amendment no 32/49/2010-11-PVSE dated 19.08.2010 and different orders and circulars related to this programme.</p>

16	<p>There is no restriction, to issue bid document to any intending bidder. The interested bidders may obtain the bid document on submission of formal request on official letterhead referring the NIT number and name of the work along with cost of bidding document for an amount of Rs.1,000 + 4.04 % sales tax.</p>
17	<p>The bid shall be of two parts and shall have to be submitted simultaneously in two separate envelopes containing (a) PART-I: Minimum Eligibility and Techno-Commercial Bid and (b) PART-II: Price Bid. All parts of the bid shall have to be submitted in sealed envelopes.</p> <p>During evaluation of the techno-commercial offer(Part-I offer), the bidder who will comply the minimum eligibility criteria shall only be considered for evaluation of Techno- Commercial Bid . After evaluation of Bid Part –I, the offer of the responsive bidders shall be considered and their Part –II, i.e. Price Bid offer will be opened in due course and shall be intimated before opening. Part – I Bid should not contain any indication of price of any item. In such cases, even if it is found anywhere, shall not be given any cognizance.</p> <p>The bid must be submitted by Registered Post /Speed Post/Hand/courier so as to reach within the due date and time for submission of offer. Any bid received after the due date and time of submission on account of delay of any kind shall not be opened.</p>
